HALL RENTAL AGREEMENT

1. Palmdale VFW Post 3552 reserves the right to refuse Service to anyone at any time.
2. The Post is a SMOKE FREE facility. Smoking is not allowed in the building or within 20 feet of any outside door.
3. All renters and guests of the renters will adhere to all posted rules, as well as local, state and federal laws.
4. **All alcoholic drinks and beverages must be purchased at The Canteen. The drinks may not be taken outside. Let your guests that attend know that if they bring alcohol it will be dumped out.**
5. All renters and guests MUST supervise children at all times. They must be with an adult and stay inside the facility.
6. If the renter has a cook that uses propane or an open flame source, it must be outside of the building.
7. The renter is required to provide their own liability insurance for the use of the facility.
8. Renter is to check the facility when opening and closing.
 - a. Trash to be taken to the dumpster.
 - b. Restrooms clean, trash picked up and emptied, countertops dry.
 - c. Hall and hallways must be swept.
 - d. Tables and chairs to be cleaned.
In order to get your \$50.00 deposit back.
9. If DAMAGES occur or the premises are left in an unacceptable condition, costs to repair or clean will be taken from the cleaning and damage deposit. If these costs exceed the amount of the deposit, renter will pay the difference.
10. Renter is responsible for fires, theft and any damages occurred during or as a result of the event.
11. Any cancellation of this event and rental agreement must be within 30 days of the event. If cancellation is less than 30 days the renter understands that any deposit is forfeited.
12. VFW Post 3552 is not responsible for changes in weather conditions or acts of nature.
